In the exercise of powers conferred under provision of Article 309 of the constitution of India, the Governor of Bihar is hereby pleased to make the following rules to regulate the mode of appointment and service conditions of Bihar Sub ordinate Statistical Cadre.

**1. Short Title, Extent and commencement**

- (i) These rules may be called the Bihar Sub-ordinate Statistical Cadre Rules,2020.
- (ii) It shall extend to the whole of the State of Bihar.
- (iii) It shall come into force with immediate effect.

**2. Definitions**

In these Rules, unless the context otherwise requires :-

- (i) "Governor" means the Governor of Bihar.
- (ii) " State Government" means the Government of Bihar.
- (iii) "Administrative Department" means the Directorate of Economics & Statistics (Department of Planning and Development).
- (iv) "Commission" means the Bihar Staff Selection Commission.
- (v) "Appointing Authority" means the Director, Directorate of Economics & Statistics, Department of Planning & Development, Govt. of Bihar.
- (vi) "Cadre" means Bihar Sub-ordinate Statistical Cadre.
- (vii) "Member of cadre" means Sub Statistical Officer/ Block Statistical Officer (prior known as Junior Statistical Assistant/ Block Statistical Supervisor/ Investigator)post holder and promoted personnel on the post of Assistant Statistical Officer.
- (viii) "Schedule" means Schedule appended to this rule.

**3. Constitution of the cadre**

- (i) This cadre shall be a State Cadre under the administrative control of Directorate of Economics & Statistics, Department of Planning & Development, Govt. of Bihar.
- (ii) Different categories of posts in this cadre will be as follows:-

| SL no | Designation   | Category             |              |
|-------|---|----------------------|--------------|
| 1     | Sub Statistical Officer/<br>Block Statistical Officer | Basic Grade Level    | Non Gazetted |
| 2     | Assistant Statistical Officer                         | 1st Promotional post | Non Gazetted |

- (iii) The number of sanctioned strength of different categories of this cadre and pay scale/ pay level shall be determined by the State Government from time to time. From time to time, the State Government shall be at liberty to create/ abolish the permanent/ temporary post of this cadre in addition to the sanctioned posts of this cadre.
- (iv) Persons already appointed/working in the said category before commencement of these rules shall be deemed to be included in cadre automatically.

#### **4. Source of Recruitment:-**

- (i) Ninety three percent of sanctioned posts of Basic Grade of this cadre like Sub Statistical Officer/ Block Statistical Officer shall be filled up through the direct recruitment by written competitive examination conducted by the commission and rest seven percent posts will be filled up by promotion from the cadre of compiler.
- (ii) Minimum qualification, subject and syllabus for Competitive Examination for direct recruitment shall be prescribed by the State Government and Commission from time to time in accordance with established rules and provision.
- (iii) The merit list shall be valid for a period of one year from the date of its receipt in the department from commission.
- (iv) The Appointing Authority shall calculate the categorywise number of vacancies on 1st April of each year and send the requisition to the commission by 30th April of every year.

#### **5. Qualification for Direct recruitment**

- (i) Age Limit:- Minimum age limit for direct recruitment will be 21 years and maximum age will be such as prescribed by State Government (General Administration Department) from time to time.
- (ii) For direct recruitment to this post candidate must be graduate from recognized university in either of the three subjects only namely Economics/Mathematics/Statistics.
- (iii) Preference and relaxation in age will be given to such candidates who have worked as Sub Statistical Officer/ Block Statistical Officer (Junior Statistical Assistant/Block Statistical Supervisor/Investigator) on contract basis:-
  - (a) Such candidates who have worked as Sub Statistical Officer/ Block Statistical Officer (prior known as Junior Statistical Assistant/ Block Statistical Supervisor/ Investigator) on contract basis they will be entitled for preference of 5 percent marks (Maximum 25 percent) for working experience of each complete year. This preference will be for preliminary and main examination conducted by commission.
  - (b) There will be relaxation in maximum age equivalent to period of service rendered by the candidates in contract basis.
  - (c) Preference of working experience and relaxation of age will be admissible for work done by contractual employees on similar post.

#### **6. Probation period/Departmental Examination/Confirmation**

- (i) Every Employee appointed against the basic post, shall be on probation for a period of two years. Probation period may be extended for one year if the appointing authority is satisfied that probationer may improve during the extended period. If the services are found unsatisfactory during extended period, services of employee may be terminated.
- (ii) After qualifying the Hindi noting and drafting examination and computer efficiency test as prescribed by the State Government, service of the employees will be confirmed by the Appointing Authority.
- (iii) Without passing the Hindi noting and drafting examination as well as computer efficiency test no any further increment will be admissible to the employee after giving the first increment.

#### **7. Seniority:-**

The inter seniority of the direct recruits shall be on the basis of recommendation of merit list received from the commission.

**3. Promotion:-**

- (i) The employees of this cadre will be promoted after completion of time period on different post fixed by General Administration Department Bihar.
- (ii) In this cadre cent percent posts of Assistant Statistical Officer will be filled up by promotion based on inter se seniority cum merit for the post holder of Sub Statistical Officer/Block Statistical Officer.
- (iii) Employees of this cadre will be promoted on the basis of recommendation of Departmental Promotion Committee.

**9. Reservation:-**

It shall be compulsory to follow Act/Resolution/Instruction/Roster prescribed from time to time by State Government (General Administration Department) regarding reservation policy in recruitment and promotion on higher post.

**10. Training:-**

A member of this cadre may be sent on training within or outside the state for such a period as the State Government may determine. The assessment of an employee on the completion of the training may be taken into consideration by the Departmental Promotion Committee at the time of promotion.

**11. Other Service conditions:-**

Other service conditions applicable to this cadre such as disciplinary action, leave, retirement benefits etc shall be governed by the respective rules framed by State Government (General Administration Department) from time to time.

**12. Repeal & Saving:-**

- (i) The existing rules and regulations in this context are hereby repealed.
- (ii) Notwithstanding, such repeal, anything done or any action taken under the existing rules/regulations shall be deemed to be done or taken under the provision of these Rules as if these Rules were come into the force on the day on which such thing was done as such action was taken.


