No. D.E.S/Estt.9-01/2023-1033-----/ in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Bihar makes the following rules to amend the Statistics and evaluation clerical Cadre Recruitment and Promotion Rules, 2007.

1. Short title, extent and commencement. -(1) These rules may be called " Statistics and evaluation Clerical Cadre Recruitment and Promotion (Amendment) Rules, 2024".

(2) It shall extend to the whole of the state of Bihar.

(3) It shall come into force at once.

2. **Amendment of Rule 1 (i) of Statistics and Evaluation Clerical Cadre Recruitment and Promotion Rules, 2007 . Sub rule (i) of Rule 1** of the said rules shall substituted as follows:

" (i) These rules may be called Economics and Statistics Clerical Cadre Recruitment and Promotion Rules, 2007".

3. **In Rule 2 (iii) of Statistics and evaluation Clerical Cadre Recruitment and Promotion Rules, 2007.Amendment. Sub-rule (iii) of rule 2 of the said rules shall amended as follows:-**

2(iii) "Appointing Authority" means the Director, Directorate of Economics and Statistics, Bihar, Patna.

4 **Amendment in Rule 2 (vii) of Statistics and evaluation Clerical Cadre Recruitment and Promotion Rules, 2007, Sub-rule (vii) of Rule 2 of the Said rules is amended as follows :-**

2 (iii) "Directorate" means Directorate of Economics and Statistics, Bihar, Patna.

5. **Amendment in Rule-4 of Statistics and evaluation Clerical Cadre Recruitment Promotion Rules, 2007.Rule 4 of the said rules is amended as follows:-**

4. Source of recruitment (i) 75% (seventy five percent) of the authorized strength of the basic category (Lower Division Clerk) posts of the cadre will be filled by direct recruitment and such recruitment will be done on the basis of the recommendation of the commission based on the written examination.

**(ii) Appointment can be made on compassionate grounds against the vacant posts available for direct recruitment.**

**(iii) The remaining 15% (Fifteen Percent) of the total posts created will be appointed on the recommendation of the departmental promotion committee by promotion on the basis of seniority cum merit from intermediate passed office attendants /attendants (special) working in the regular establishment of the Directorate of Economics and Statistics. Will be filled by the authority.**

**But the lower category clerks promoted in this manner will not be given the next increment after promotion and the first increment unless they pass the Computer Competency Test and Hindi Noting and Drafting Test. After passing the said examination, their service can be confirmed on the post of lower division clerk.**

(iv) The remaining 10% (ten percent) posts of the authorized force will be filled by excellent national level sportspersons of the state of Bihar. The "appointment of national level outstanding players will be done under the provisions contained under the Appointment Rules of Bihar Excellent Players" of the General Administration Department.

**6 Statistics and evaluation Clerical Cadre Recruitment and Promotion Rules, 2007 Amendment in Rule-5 (ii). Sub-rule (ii) of Rule 5 of the said Rules shall amended as follows:-**

5(ii) Minimum educational qualification. The Candidate must have passed the Intermediate examination or its equivalent examination from the Bihar School Examination Board or any other board/ examination taking institution recognized by the Government of Bihar.

7. Details of sanctioned posts of clerical cadre under Statistics and evaluation, Bihar, Patna are attached as Schedule-1

**But the State Government may create or delete new posts or reorganize the cadre as per requirement from time to time.**
